

RBL Bank Popcorn Credit Card Terms & Conditions

1. INTRODUCTION:

These Terms and Conditions apply to and regulate the provision of Popcorn Credit Card by RBL Bank Limited (“RBL Bank”) offered in association with Big Tree Entertainment (“BookMy Show”). If there is a conflict between these Terms and any terms as prescribed under the Cardmember Agreement, the provisions of the Cardmember Agreement shall prevail.

2. DEFINITIONS AND INTERPRETATIONS:

- 2.1. “App” and “Website” shall mean the mobile application and the website of the Alliance Partner i.e. www.bookmyshow.com.
- 2.2. “EMI” shall mean Equated Monthly Installments.
- 2.3. “GST” shall mean the Goods and Services Tax.
- 2.4. “Card or Popcorn Card” shall mean the co-branded credit card offered by RBL Bank in association with BookMyShow.
- 2.5. “Void Transaction” shall mean any transaction wherein the transaction has taken place but has been cancelled /rejected /unsuccessful.
- 2.6. "Merchant Establishment" means establishment wherever located which honors the Card and shall include among others, stores, shops, restaurants, hotels, airlines, cash advance points including ATMs and mail order advertisers (whether retailers, distributors or manufacturers) and shall include establishments which honor the Card online.
- 2.7. "Merchant" means any person who owns or manages or operates the Merchant Establishment, its successors and permitted assigns.
- 2.8. Unless otherwise defined, the capitalized terms used in these Terms will have the same meanings as ascribed to them in the Cardmember’s Agreement.

3. PRODUCT OFFER:

- 3.1. The Cardmember is offered an attractive ‘welcome benefit’ on availing the Popcorn Card:
The Cardmember applying for Popcorn Card is entitled to a ‘welcome benefit’ of INR 1,000 on purchasing movie tickets directly on the App and/or Website at the time of check-out. In order to redeem the benefit, Cardmember needs to click on the ‘RBL Bank Welcome Offer’ under the Offer section on the App and/or the Website and thereafter is required to enter the Card details to initiate valid transaction. The Offer is redeemable for two transaction of INR 500 each or a maximum value of 2 movie tickets in each transaction, whichever is less. The Cardmember’s Account shall be credited with the Offer amount provided the Popcorn Card is swiped within 30 days of the issuance by RBL Bank and upon payment of annual fee for the first year by the first payment due date.
- 3.2. Monthly benefit of INR 500 on BookMyShow movie tickets (“Reward Points”):
The Cardmember has an exciting chance to get INR 500 off or cost of 2 movie tickets, whichever is less on BookMyShow movie tickets, if the Cardmember makes valid transactions equal or greater than INR 5,000 in one Billing Cycle. The qualifying Purchase value for the monthly benefit shall be exclusive of all EMI transactions, cash withdrawals, fees (if any), charges and GST. The Cardmember will be able to use this Offer directly on the App and/or Website at the time of check-out. At the time of check-out the Cardmember should click on ‘RBL Bank Monthly Offer’ under the Offer Section to enjoy the benefits of this Offer. This Offer is valid and applicable for a single transaction or maximum value of 2 movie tickets, whichever is lower.
- 3.3. Weekly cashback benefit for at least a minimum value of INR 25 (“Cashback”):
The Cardmember will become eligible for Cashback on valid transactions made during Monday to Sunday for a total amount of INR 2, 500. The Cashback will be credited directly into the

Cardmember's Account within 2 work days from the date of redeeming the Offer. This Cashback shall only be credited to eligible Cardmember if the Cardmember visits the unique redemption link and the OTP is verified by RBL Bank. The Cardmember can redeem the Cashback from Tuesday midnight and within one week of being eligible. The Cashback for a particular week shall expire on the consecutive week's Monday midnight. The qualifying purchase value for the weekly benefit shall be exclusive of all EMI transactions, cash withdrawals, fees (if any), charges and GST.

3.4. Petrol surcharge waiver:

Upon every petrol purchase for an amount between INR 500 and INR 4,000 (inclusive of both the amounts and excluding the surcharge amount) made by the Cardmember with the Popcorn Card, the Cardmember is eligible for the petrol surcharge waiver. The Cardmember shall receive a waiver on the petrol surcharge up to INR 100 every month. The Cardmember recognizes and understands that any petrol Purchase for an amount of INR 499 or lower shall not be eligible for the petrol surcharge waiver and the Cardmember shall continue to be levied with a surcharge amount of INR 10. The Cardmember also recognizes and understands that any petrol Purchase for an amount of INR 4,001 and above shall not be eligible for the petrol surcharge waiver and will continue to be levied with a surcharge amount equivalent to 1% of the total transaction amount. Eligible petrol Purchases made at petrol pumps will be levied with applicable petrol surcharge amount at the time of the Purchase and this will be appear on the Cardmember's Statement. This surcharge will subsequently be reversed for eligible transactions. The levied surcharge will not be reversed for transactions which are not eligible for the petrol surcharge waiver i.e. transactions worth INR 499 and below and INR 4,001 and above. A consolidated reversal of the surcharge amount will be reflected in the Cardmember's Billing Statement. The Cardmember understands that GST shall be levied on the petrol Purchase and the same shall not be reversed. The petrol surcharge waiver shall not be extended to delinquent or over-limit or closed Popcorn Cards.

4. GENERAL TERMS AND CONDITIONS:

- 4.1. RBL Bank does not guarantee and make any representation about the usefulness, worthiness and/or character of the discount / benefit provided on the Card. Any tax or other liabilities or charges payable to the government or any other statutory authority/body or any participating establishment, which may arise or accrue to the Cardmember due to provision of the offer, shall be to the sole account of the Card Member. Tax deducted at source, if any, on the monetary value of the Offer shall be payable by the Cardmember. RBL Bank reserves the right to disqualify the Cardmember from the benefits of the Offer if any fraudulent activity is identified as being carried out for the purpose of availing the benefits under the Offer or otherwise by use of the Card. RBL Bank shall not be held liable for any delay or loss that may be caused in delivery of the product and services or the assured gifts / prizes.
- 4.2. RBL Bank and BookMy Show reserve the right, at any time, without prior notice and without assigning any reason whatsoever, to add/alter/modify/change or vary these terms and conditions or to replace, wholly or in part by another offer, whether similar to this offer or not, or to extend or withdraw it altogether. The offer provided on the Popcorn Card cannot be clubbed with any other offers that may be available to the Cardmember by Bookmy Show and RBL Bank and the offers there under not transferable. The Offer is not valid and applicable for Void Transaction. The offer's cannot be clubbed/combined/exchanged with any other offer running at the said App and/or Website. This Offer is valid only for successful/approved transactions and not void transactions
- 4.3. RBL Bank will also not be liable for any consequences connected with the use/ misuse of the Card by any third party due to the Card falling in the hands of any third party or the PIN coming to the knowledge of any third party. If any third parties gain access to the services, including the Card Account, the Card Member will be responsible and shall indemnify RBL Bank against any liability, costs or damages arising out of such misuse / use by third parties based upon or relating to such access and use, or otherwise.

- 4.4. Any disputes as regards delivery, quality, merchantability or suitability of products/services availed of under this offer must be addressed by the Cardmember in writing to Bookmy Show directly and RBL Bank will not entertain any communication in this regard. Any disputes/ queries as regards to the use, loss, fraudulent use or any other reason relating to the Popcorn Credit Card must be addressed by the Cardmember in writing to RBL Bank and Bookmy Show will not entertain any communication in this regard. RBL Bank or Bookmy Show shall not be liable for any loss or damage whatsoever that may be suffered, or for any personal injury that may be suffered, to a Cardmember, directly or indirectly, under this scheme/the Voucher. This Offer shall be subject to all applicable laws, rules and regulations which are in existence and which may be promulgated anytime by any statutory authority.
- 4.5. These terms and conditions shall be governed by the laws of India and any dispute arising out of or in connection with these terms and conditions shall be subject to the exclusive jurisdiction of the courts in Mumbai & RBL Bank reserves the right to add, alter, modify, change or vary any of these terms and conditions or to replace, wholly or in part, this offer by another offer, whether similar or not, or to withdraw it altogether at any point in time, without any prior notice. The above Offer is by way of a special Offer for Cardmembers and nothing contained herein shall prejudice or affect the terms and conditions of the card member agreement. The terms of the above schemes shall be in addition to and not in derogation of the terms contained in the Card member agreement.
