

## RBL BANK MONEYTAP BLACK CREDIT CARD TERMS AND CONDITIONS

### 1. INTRODUCTION:

These Terms and Conditions apply to and regulate the provisions of RBL Bank MoneyTap Black Credit Card issued by RBL Bank Limited ("RBL Bank") offered in association with "MWYN Tech Pvt Ltd" and should be read in conjunction with the Cardmember Agreement. If there is a conflict between these Terms and any terms as prescribed under the Cardmember Agreement, the provisions of the Cardmember Agreement shall prevail.

### 2. DEFINITIONS AND INTERPRETATION:

- 2.1. "Account" or "Card Account" shall mean an account maintained by RBL Bank under these terms and conditions, in the name of the Cardmember.
- 2.2. "App" shall mean the mobile application and the website of the Alliance Partner i.e., [www.bookmyshow.com](http://www.bookmyshow.com).
- 2.3. "Anniversary year" shall mean 12-month period commencing from the date of the credit card account opening to card renewal date and from renewal date to next renewal date subsequently.
- 2.4. "Card" or "RBL Bank MoneyTap Black Credit Card" shall mean the credit card issued by RBL Bank.
- 2.5. "Cardmember/s" or "Primary Cardmember/s" shall mean such customers to whom a Card has been issued and who is authorized to hold the Card. The use of terms 'you' and 'your' shall mean the Cardmember wherein the context admits.
- 2.6. "EMI" shall mean Equated Monthly Instalments.
- 2.7. "GST" shall mean the Goods and Services Tax
- 2.8. "INR" shall mean Indian National Rupee.
- 2.9. "Merchant Establishment" means establishment wherever located which honours the Card and shall include among others, stores, shops, restaurants, hotels, airlines, cash advance points including ATMs and mail order advertisers (whether retailers, distributors, or manufacturers) and shall include establishments which honour the Card online.
- 2.10. "Merchant" means any person who owns or manages or operates the Merchant Establishment, its successors and permitted assigns.
- 2.11. "Offer" shall mean such benefits given by RBL Bank on purchase of products/services using RBL Bank services.
- 2.12. "Statements" shall mean the Card Statement sent by RBL Bank to its Card members at periodic intervals indicating the payment credited and the transaction debited to the Account and the charges (if any) as applicable along with the payment required by the payment due date as applicable.
- 2.13. "Website" shall mean [www.rblbank.com](http://www.rblbank.com)
- 2.14. "Void Transaction" shall mean any transaction wherein the transaction has taken place but has been cancelled /rejected /unsuccessful.

Unless otherwise defined, the capitalized terms used in these Terms will have the same meanings as ascribed to them in the Cardmember's Agreement.

### 3. PRODUCT OFFER:

#### 3.1. 'Welcome benefit' on availing the RBL Bank MoneyTap Black Credit Card:

The Cardmember can avail a onetime benefit of 12000 reward points as welcome benefit. The Cardmember can avail this welcome benefit by paying the annual fee and upon card activation within the first 30 days from card issuance. The 'welcome benefit' will be credited to the Cardmember's Account within 60 days from the date of the Card issuance.

Spends will be calculated only for settled transactions, basis the transaction date submitted by the Merchant Establishment/ Association (i.e. MasterCard/VISA). RBL Bank shall not be held responsible if Merchant Establishment submits the transaction date as different from the actual date when the transaction was done. The Cardmember can redeem the reward points from [www.rblrewards.com](http://www.rblrewards.com). For more details, refer to [www.rblrewards.com/tnc](http://www.rblrewards.com/tnc).

#### 3.2. Movie benefit of upto INR 100 on BookMyShow movie tickets:

The Cardmember can avail a 'movie benefit' of 10% discount on movie tickets of a maximum amount of INR 100, any day of the week, upto 15 times in a year, on booking movie tickets on BookMyShow's mobile application or BookMyShow's website i.e. [www.bookmyshow.com](http://www.bookmyshow.com) using the Card. This 'movie benefit' will be valid on any day of the week. It is hereby clarified that the 'movie benefit' shall be applicable only on the primary Card, and not on add-on Cards Therefore, the 'movie benefit' will not apply if the movie tickets are booked using add-on Cards on BookMyShow mobile application and/ or BookMyShow website. In case you have applied for the 'movie benefit' but the transaction is not successful, kindly wait for 20 minutes before trying to avail the 'movie benefit' again. The Cardmember availing the 'movie benefit' is advised to check the other applicable terms and conditions of BookMyShow at [www.bookmyshow.com](http://www.bookmyshow.com) before availing the 'movie benefit'. It is hereby clarified that the tickets once purchased either from the BookMyShow mobile application or BookMyShow website, shall be considered sold and cannot be cancelled, refunded or exchanged. BookMyShow will use best efforts to ensure the Offers are provided as described, but Cardmember shall not make any claim or seek compensation against BookMyShow or RBL Bank even in the event that the Offers are not provided or provided as described.

#### 3.3. Monthly benefit of 1000 Reward points:

The Cardmember can avail 1000 Reward Points every month on making atleast 5 transactions of Rs 1000 or more. The above cashback offer is inclusive of transactions on add-on cards, if any, and there will be no exclusive offer on add-on cards. W.e.f. October 15, 2024, purchases made on select categories\*/MCCs will not be considered in the monthly benefit program. (for more details on exclusion categories and Exclusion MCC codes Refer section 3.4)

#### 3.4. Reward benefits on the RBL Bank MoneyTap Black Credit Card:

The Cardmember is eligible for 2 reward points for every valid retail transaction worth INR 100 spent on all purchases like travel, groceries, dining. The Cardmember can avail 5X Reward Points i.e. 10 Reward Points for every valid transaction worth INR 100 spent online, upto 500 Rewards Points in a month. The Cardmember understands and acknowledges that reward points earned in any given month will be credited to the Cardmember's account within 60 days from the settlement

date of eligible transactions.

Base reward points are not accrued on purchases made in categories: fuel, (9752, 5541, 5983, 5172, 5542), utilities (4900), railways (4112, 4011, 4111), rental (6513), wallet load (6540), insurance (6300, 5960) and government services (9399, 9402, 9405).

W.e.f. October 15, 2024, Base and Accelerated reward points shall also not be accrued on select categories/MCCs: Fuel & Auto, Quasi-Cash, Real Estate/Rental, Education, Wallet/Service Providers, Contracted Services, Miscellaneous, Cash, Bills2pay (Bills2Pay is a facility provided by RBL Bank where Cardmembers can pay various utility bills via RBL MyCard App/RBL MoBank App/Internet banking channel) and EMI conversion of retail transactions (Split-N-Pay & EMI conversion requests placed at the time of making transactions at POS/Web/Mobile App). Please refer to the table below for your reference.

The Cardmember agrees and understands that the spends will be calculated only for settled transactions, basis the transaction date submitted by the merchant establishment/ association (i.e. MasterCard/VISA). RBL Bank shall not be held responsible if the merchant establishment submits the transaction date as different from the actual date when the transaction was done.

### 3.5. The 'milestone program' on RBL Bank MoneyTap Black Credit Card:

The Cardmember will be entitled to get 8000 Reward Points on Annual Spends of INR 2.5 Lacs and an additional 8000 Reward Points on crossing Annual Spends of INR 4 Lacs. The Cardmember understands and acknowledges that bonus milestone reward points will be credited to the Cardmember's account within 45 days from the date of crossing the corresponding annual spend milestone.

W.e.f. October 15, 2024, purchases made on select categories\*/MCCs will not be considered in the milestone benefit. (For more details on exclusion category and exclusion MCC codes Refer section 3.4)

It is also clarified that the billed spends for the Cards includes both Primary and add-on Cards for the said period will be considered for the benefits/ reward points. The qualifying purchase value for bonus reward points will exclude all EMI transactions, cash withdrawals, fees (if any), charges and Goods and Services Tax. It is further clarified that the spends will be calculated only for settled transactions, basis the transaction date submitted by the merchant establishment/ association (i.e. MasterCard/VISA). RBL Bank will not be held responsible, if the merchant establishment submits the transaction date as different from the actual date when the transaction was done.

### 3.6. Fuel Surcharge Waiver

Upon every fuel purchase for an amount between INR 500 and INR 4,000 (inclusive of both the amounts and excluding the surcharge amount) made by the Cardmember using the RBL Bank MoneyTap Black Credit Card, the Cardmember is eligible for the fuel surcharge waiver. The Cardmember shall receive a waiver on the fuel surcharge up to INR 100 every month. The Cardmember recognizes and understands that any fuel purchase for an amount lower than INR 500 shall not be eligible for the fuel surcharge waiver and the Cardmember shall continue to be levied with a surcharge amount of INR 10. The Cardmember also recognizes and understands that any fuel purchase for an amount more than INR 4,000 shall not be eligible for the fuel surcharge waiver and will continue to be levied with a surcharge amount equivalent to 1% of the total transaction amount. The eligible fuel purchases made at fuel pumps will be levied with applicable fuel surcharge amount at the time of the Purchase and this will appear on the Cardmember's Statement. This surcharge will subsequently be reversed for eligible transactions. The levied surcharge will not be reversed for transactions which are not eligible for the fuel surcharge waiver i.e. transactions below INR 500 and above INR 4,000. A consolidated reversal of the surcharge amount will be reflected in the Cardmember's Statement. The Cardmember understands that Goods and Services Tax shall be levied on the fuel purchase and the same shall not be reversed. It is clarified that the fuel surcharge waiver shall not be extended to delinquent or over-limit or closed RBL Bank MoneyTap Black Credit Cards.

### 3.7. Domestic Lounge Access:

The Cardmember using the RBL Bank MoneyTap Black Credit Card can receive 1 complimentary domestic airport lounge visits per calendar quarter. It is clarified that the 'lounge benefit' is applicable only in select lounges in India, via MasterCard/VISA's service providers. You shall be given an access at the lounge only upon successful authorization of the Card on the electronic terminals placed at the lounges. The Cardmember will get access to the lounge and food and beverages as applicable under the agreement between MasterCard/VISA and the lounge. The Cardmember is advised to check the services and facilities that are covered in the MasterCard/VISA lounge access program. Additionally, an authorization for an amount of INR 25 will be done on the Card for the purpose of validation, however it is clarified that such authorization amount shall not be charged to the Cardmember's Account. It is hereby clarified that the Cardmember can only avail the 'lounge benefit' if the Cardmember is carrying a valid Card issued in India and only one entry into the domestic airport lounge per Cardmember shall be permitted.

The Cardmember agrees and understands that the 'lounge benefit' can be modified, amended, changed or revoked anytime by MasterCard/VISA without any prior intimation and the access to the domestic airport lounge will be available to the Cardmember only on first-come-first-serve basis.

#### **4. Additional terms and conditions for Credit Line Products:**

- 4.1 The fund transfer facility for RBL Bank "Credit Line Products" including the RBL Bank MoneyTap Black Credit Card will be subject to a successful authorization by RBL Bank of transaction initiated through the respective mobile app or Website.
- 4.2 The overall credit limit for said Credit Line Products will have a shared limit between a physical Credit Card and fund transfer facility.
- 4.3 The processing fee will be charged on each loan withdrawal as per the amount visible on the customer interface at the time of availing fund transfer.
- 4.4 Each fund transfer transaction shall be converted into EMI as per the tenure plan selected by the Cardmember and interest rate shown on respective mobile application and or Website at the time of availing fund transfer.
- 4.5 The interest rate charged on the EMI plan will be decided as per the sole discretion of RBL Bank. RBL Bank reserves the right to change interest rate offering from time to time as per its internal risk assessment policies.
- 4.6 The EMI amount for fund transfer will be charged to the Cardmembers in the Card statement as per the EMI schedule selected at the time of availing funds transfer from the respective mobile application and or Website.
- 4.7 The finance charges, late payment charges will be levied in Statement as per RBL Bank's policies and Most Important Terms and Conditions as available on the Website.
- 4.8 RBL Bank may at its sole discretion restrict and/or block the creditline functionality on the Card account basis the risk policies of RBL Bank.
- 4.9 In an event funds are not transferred to the Cardmember's Accounts instantly but gets debited from Cardmember's credit limit, the same will get reversed by RBL Bank within 5 working days from the date of such transfer.
- 4.10 Responsibility for entering correct IFSC and bank account details for fund transfer solely lies with the Cardmember. In case funds are transferred to the wrong bank account due to erroneous details entered on the app/website, the same needs to be raised by the Cardmembers with the beneficiary bank for transfer to the correct account.
- 4.11 In case the customer decides to pre-close a credit-line transaction, he/she would have to write to [cardservices@rblbank.com](mailto:cardservices@rblbank.com) or contact RBL Bank customer care on the official help-line number, requesting for a pre-closure of the credit-line transaction. No pre-closure charges will be levied. Additionally, the processing fee shall be reversed if the full payment has been done within the stipulated cooling off period.
- 4.12 Money transfer may also happen with NEFT.

Please note that w.e.f 20th November 2024, Credit Line functionality for your RBL Bank MoneyTap Black Credit Card will be available on the RBL Bank MyCard mobile application under XpressCash program. This feature available on the partner mobile application will no longer be available for you to opt for.

Steps to avail XpressCash after logging in to the MyCard application are explained below:

- Click on the banner "Get Instant Cash"
- Enter details like Loan amount, tenure etc.
- View EMI, Interest rate, proc fee etc.
- Enter bank account details (A/c no. & IFSC code)
- Get the amount credited within 3-4 working days

- 5.1 RBL Bank does not guarantee and make any representation about the usefulness, worthiness and/or character of the discount / benefit provided on the Card.
- 5.2 Any tax or other liabilities or charges payable to the government or any other statutory authority/body or any participating establishment, which may arise or accrue to the Cardmember due to provision of the Offer, shall be to the sole account of the Cardmember. Tax deducted at source, if any, on the monetary value of the Offer shall be payable by the Cardmember.
- 5.3 RBL Bank reserves the right to disqualify the Cardmember from the benefits of the Offer if any fraudulent activity is identified as being carried out for the purpose of availing the benefits under the Offer or otherwise by use of the Card. RBL Bank shall not be held liable for any delay or loss that may be caused in delivery of the product and services or the assured gifts / prizes.
- 5.4 RBL Bank reserves the right, at any time, without prior notice and without assigning any reason whatsoever, to add/alter/modify/change or vary these terms and conditions or to replace, wholly or in part by another offer, whether similar to this Offer or not, or to extend or withdraw it altogether.
- 5.5 The Offer is valid only for successful/approved transactions and not applicable for Void Transaction. The Offer's cannot be clubbed/combined/exchanged with any other offer running at the said mobile application of RBL Bank/or Website.
- 5.6 RBL Bank will also not be liable for any consequences connected with the use/ misuse of the Card by any third party due to the Card falling in the hands of any third party or the PIN coming to the knowledge of any third party. If any third parties gain access to the services, including the Card Account, the Cardmember will be responsible and shall indemnify RBL Bank against any liability, costs or damages arising out of such misuse / use by third parties based upon or relating to such access and use, or otherwise.
- 5.7 This Offer shall be subject to all applicable laws, rules and regulations which are in existence and which may be promulgated anytime by any statutory authority.
- 5.8 These terms and conditions shall be governed by the laws of India and any dispute arising out of or in connection with these terms and conditions shall be subject to the exclusive jurisdiction of the courts in Mumbai & RBL Bank reserves the right to add, alter, modify, change or vary any of these terms and conditions or to replace, wholly or in part, this Offer by another offer, whether similar or not, or to withdraw it altogether at any point in time, without any prior notice.
- 5.9 RBL Bank shall not be responsible or liable in any manner whatsoever for any deficiency or inadequacy of service rendered by BookMyShow for any loss whatsoever of any nature suffered by any Cardmember.
- 5.10 The above Offer is by way of a special offer for Cardmembers, and nothing contained herein shall prejudice or affect the terms and conditions of the card member agreement. The terms of the above schemes shall be in addition to and not in derogation of the terms contained in the Card member agreement.
