

DETAILS OF THE CARD BENEFIT (OFFER)

Terms & Conditions

A. Definitions:

- 1. **"Alliance Partner"** shall mean "Future Retail Limited", who has entered into an Alliance Agreement with RBL Bank for the purpose of providing the Offer.
- 2. "Card" shall mean a RBL Bank and Bajaj Finserv co-branded credit card, i.e. SuperCard issued by RBL Bank.
