

Offer:

I. Definitions

- "Cardholder(s)" shall mean a customer of RBL Bank, holding a valid and active Debit Card.
- "Card" shall mean a VISA /MasterCard Debit Card, which has been issued by RBL Bank to the Cardholder(s) and is valid and subsisting during the Offer Period.
- "Spends" shall mean all purchase transaction on any website/mobile application or at any
 merchant Point of Sale terminal/retail outlet (excluding cash withdrawals at ATMs and
 banks, Void Transactions,) for making payment against purchase of any product or services
 by a Cardholder, during Offer period,. For this, the Bank will consider transactions done
 between 0 Hrs. to 24 Hrs. IST.

• "The Top 100 Highest Spenders" shall mean the 100 highest spenders (other than the Highest Spenders of the Week qualifying for Gift 1) carrying out spends of not less than Rs.25,000/- on the Card, during the Program Period



• "Void Transaction" shall mean any transaction wherein the transaction made by using the Card has been canceled by the merchant establishment prior to settlement with RBL Bank.

II. Terms & Conditions:

- The Offer is open to select Cardholder/s holding a valid and subsisting Card during the Offer
 Period and have received the communication from the bank regarding the offer
- In order to be eligible to qualify for Gift 1, Cardholder needs to have Cumulative 'Spends' of minimum Rs.1.5 lacs on his card in a week during the Offer period
