

DETAILS OF THE CARD BENEFIT (OFFER)

Terms & Conditions

A. Definitions:

- I. "Alliance Partner" shall mean "Bajaj Finserv", who has entered into an alliance agreement with RBL Bank for the purpose of providing the Offer.
- II. "Card" shall mean a Visa/Master Credit Card issued by RBL Bank.
- III. "Card Member/s" shall mean such customer/s to whom a Credit Card has been issued and who is authorized to hold the Card.
- IV. "Offer" shall mean such discount/joint benefits given by the Alliance Partner and RBL Bank on purchase of Products/Services
